This is fun, but challenging work, and the camaraderie of our efforts reflects the best of the human spirit. We are thankful for the tireless dedication of our team and hope that your participation in the event, and liberal use of your bidding paddles (credit cards, cash and so forth), will reflect favorably on these facts.

The work that OHA and others do to support our wildlife professionals, wildlife enforcement, shape legislation and drive habitat maintenance and enhancement activities are absolutely critical to maintaining our privileges as sportsmen and sportswomen.

Arthur R. Dubs Foundation Youth Grant:

RVOHA is absolutely delighted to advise the membership that our efforts at garnering support for the important work of our organization continues and this spring, our youth efforts will be heavily subsidized and sponsored by the Arthur R. Dubs Foundation (ARDF). RVOHA was advised that it was awarded an \$8000 grant to support our continued efforts in support of the Rogue Valley's sporting youth. This grant will support the expansion of our participation in the Spring Turkey Hunting Clinic (which we intend to make a two-day event), underwrite a significant portion of YOH (Young Oregon Hunters) Day, as well as other programs we are in the process of finalizing.

In addition to this grant, RVOHA will be participating in the Responsive Grant process this spring and has a tentative summary ask of approximately \$25,000. The ARDF spring Responsive Grant cycle is for the July through June period. As a result, the RVOHA grant request will include a year's worth of youth related support, including the efforts already described, as well as supporting our local high school trap shooting teams, supporting the new Crater High School Outdoor Experience Hunter Education curriculum, our annual support of the Denman youth pheasant hunt, in addition to several other initiatives currently in development.

Oregon State Police Report:

- A Senior Trooper located a vehicle in a closed unit for deer archery. The vehicle had two bow cases in the back seat. Eventually two hunters emerged, were questioned and then cited when the trooper advised them they were not in the unit they thought they were in.
- OSP Pilot spotted a vehicle driving inside the JACTMA Road Closure by Butte Falls. The vehicle came out on one of the closed roads as a trooper was standing by, waiting. The single occupant, an archery hunter, was unaware of the road closure and cited for Violation of Travel Management Agreement. Further investigation revealed that the vehicle had driven right by a "Closed Road" sign.
- A Central Point Trooper doing night patrol stopped a vehicle on a mountain road near Gold Hill. The plates on the vehicle were switched. The occupants were not poachers, however, they did have an unlawful load of forest products. Several citations/warnings were issued in regard to forest product violations and traffic offenses.
- Central Point Troopers responded to a couple of duck hunting complaints along the Rogue River. One complainant actually had the windows broken in their residence from birdshot. The other complaint was two hunters that were legal - this is a common complaint OSP receives, where landowners along the river don't like people hunting the river.
- While working the Jackson road closure areas, Troopers checked numerous archery deer hunters and several ATVs, one of which was reported to have been in the closure. When contact was made, it was on an open road. The driver admitted to being in the closure, but it was not witnessed by a Trooper. He was warned and provided a map.

The intent of this letter is to provide you with some resources to help you get started with the new system.

One of the main frustrations has occurred when someone creates a new profile in our system without first verifying their old profile. Before you do anything else with the new system, please verify your account at:

This page includes helpful videos on how to verify your account and avoid the problem mentioned during the presentation, as well as how to make on-line purchases. Please check it out at:

If you have been frustrated by the new system, or don't find the links above helpful, please call our office, or stop by and see us. We can help you verify your account, purchase your tags and licenses, and even do your mandatory reporting (even if you don't have an email).

Eventually, we will get back to enjoying our hunting, fishing, and family traditions, and the details about how we get our tags and licenses will become a background issue again, like they should be. Position statements (also due February 1st) of up to 200 words may be submitted for publication in the election section of Oregon Hunter magazine.

- Prepare for, attend and participate in State Board meetings, which typically include four face-to-face board meetings per year scheduled throughout the state, and up to six teleconference board meetings per year.
- Actively work on projects or current issues. This may include management plan reviews, serving on a special work group, pursuing a specific legislative action, developing OHA policies or positions, tracking and responding to external issues, etc.

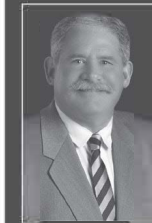

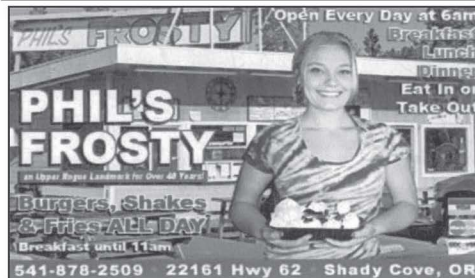

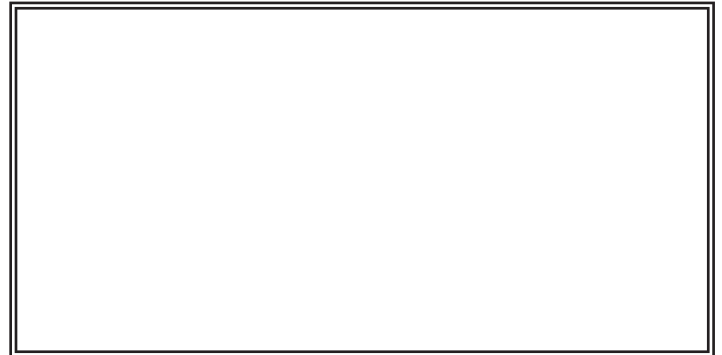
