### **The Power of the RVOHA Voice:**

RVOHA has a pretty decent voice being roughly 1000 members strong, coupled with the resolve and financial means, to take on challenging opportunities if we so choose. Recently we partnered with ODFW to offer a Predator Hunting Presentation biased to effective techniques for hunting Black bear and Cougars. RVOHA, with considerable support from Coastal Farm and Ranch, provided some electronic calls as raffle items for those in attendance and everyone seemed to have appreciated the evening's content. ODFW offered some light snacks, beverages and some excellent cougar sausage(s) to support everyone's comfort for the two hour event. It felt like a very pleasant party of sorts.

The presentations were very informative - Steve Niemela, Sam Doddenhoff and Scott Napoli did an outstanding job of explaining predator behavior and considerations for managing this part (predators) of the Oregon ecosystem from a biological and public relations perspective (management plans). Sam provided some great suggestions for pursuing Black bears during both the spring and fall hunting seasons. His experience and passion were in evidence throughout his presentation. Scott was equally adept in describing his interest in Black bears, but more particularly with respect to cougar hunting with an emphasis on calling techniques. It was clear Scott is a subject matter expert and completely open to sharing all that he's learned through trial and error. Classes like this should be routinely available, but for that to happen we have to have energy and commitment to support them. That energy needs to come from an expanded group of earnest fundraisers and participants - how about joining in the fun?

There are so many opportunities for RVOHA to be the leading voice and advocate for our individual and collective interests. Our funding efforts to support some of these ambitions will come to fruition on March 14th. Everyone's in a different place, but here's where we're all the same. We all have something to give/offer. His willingness, and ability, to engage legislators, wildlife professionals and opinion leaders is deeply-valued and he has left an indelible mark in shaping the conversations on many issues important to OHA members. ### **Oregon State Police Report:**

On Monday January 13th Senior Trooper received information of two individuals that were caught by a security guard attempting to dump Jack Dempsey fish in the Josephine County sports park pond. The security guard advised them that they couldn't do that and one of them, in-substance, said something about dumping them in the Rogue River. A license plate of the vehicle was gathered and trooper is following up.

On Saturday January 18th Senior Troopers assisted patrol on a crash investigation after OSP was advised by a local tow company that an individual called them directly and said his vehicle had slid off the road and into the creek and needed it towed out. When troopers arrived on scene in a section of the Rogue River, between Rogue River and Gold Hill, they found that the vehicle had actually been involved in a serious vehicle crash that had veered off the roadway and down an approximate 50' cliff while hitting a few trees along the way. The vehicle was split into four separate pieces with most of them in the Rogue River clearly leaking fluids. When the driver arrived back on scene with, surprisingly, only scrapes and bruises he said it had occurred the night before and failed to report it. Trooper advised him that fluids had been leaking all night and most of the day into the Rogue River and that he was being cited for water pollution II. The driver was also cited for driving while suspended misdemeanor and failure to perform duties of a driver.

Trooper attended a CORSAR (California Oregon Regional Search and Rescue Task Force) meeting in Grants Pass on January 14th. Multiple agencies throughout southwest Oregon and California are part of this group which aid in providing SAR services to each other. Trooper discussed OSP aviation assets and the assistance we can provide.

On January 15th, Trooper provided aerial assisted to Game Troopers and Jackson County SO Forest Deputies attempting to locate a wanted individual associated with transient camps in the Star Gulch area of the Applegate Valley. Possible game and forest product violations also were associated with these camps. A couple of vehicles and camps were located, but turbulent air conditions prevented more thorough coverage. Officers on ground did make contact with occupants and gathered information.

Trooper conducted a traffic stop on a vehicle pulling a camp trailer on the Tiller/Trail Highway. Three occupants were contacted and the camp trailer looked to have lots of trash within it. The occupants claimed they had been evicted and were looking for another place to park it. When asked, they denied attempting to dump/abandon the trailer in the woods. The driver was found to be DWS and driving uninsured resulting in citations. A male occupant was identified and found to have a Parole Violation warrant out of Jackson County. The wanted male occupant was taken into custody and transported to Jackson County Jail where he was lodged under the Parole Violation. The occupants were made aware that if the trailer was found dumped in the area, they would be tracked down.

On January 17th, Trooper attended a restitution hearing on a criminal wildlife case involving a John Brandon Shawnego. In 2017, Shawnego had been charged with Unlawful Take of a Buck Deer with a rifle during late archery season. Shawnego also was charged with Felon in Possession of Firearm. Shawnego agreed to accept a deal which involved him pleading guilty to one felony charge of Felon in Possession of Firearm. The wildlife misdemeanors were dismissed with the fact Shawnego agree to pay \$7500 restitution for the unlawful take of a 3x4 buck blacktail deer. Shawnego argued this restitution value was unreasonable and asked for a hearing. The judge found Oregon statute was clear in the language requiring a buck deer of this class be valued at \$7500. The judge held the restitution owed to the state in full. Shawnego's hunting and fishing privileges were suspended for one year and the rifle was seized as evidence was forfeited.

### **High School Shooting Sports Teams:**

The upcoming season is just around the corner and there will now be at least three (3!!!) teams representing the Rogue Valley. ## **ODFW Report:**

**Bear Control Hunt Deadline:** 'Tis the season to be applying for a spring bear. The application deadline is Feb 10 with results available Feb 20. For SW Oregon, there are 4400 tags available - in 2019 there were 4065 1st choice applicants

**Hunt to Home:** For hunters, new or well-seasoned, we would love to share an opportunity to learn a few game processing tricks as you head afield to hunt, after you've pulled that trigger/loosed that arrow and finally are putting your harvest on the table. Oregon State University Extension Services has created a two-day class called Hunt to Home. On the first day, you will learn methods of eviscerating, skinning and cooling your animal's carcass and ODFW will be there to discuss wildlife health and what to watch for in terms of potential pathogens. The second day will teach you how to butcher, wrap, pressure can and make your own jerky. You will also learn safe handling practices and sanitation. The classes will be Saturday March 21 and 28 from 9 A.M. to 3 P.M. You can participate in one class or both. Cost is \$20 for 1 day, or \$35 for both. 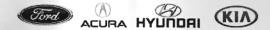

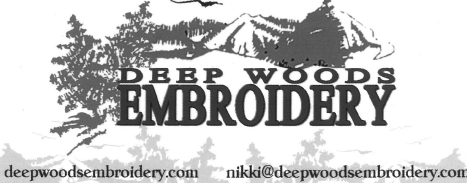

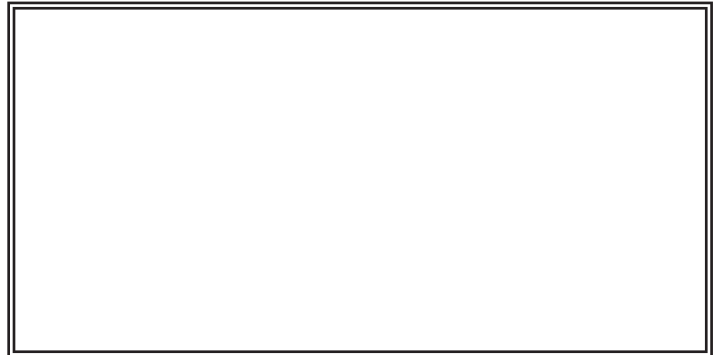
