If you can, this is an amazing opportunity to make some lemonade out of a whole truckload of lemons - all those places you wanted to check for a Tom or a Yogi are still there and while you might not want this extra time on your hands, for now, there are people declaring you might need to do something else to manage your time. With some scouting you might end up seeing this guy on April 15th - previously tax day (which now appears will be July 15th - and we do hope you'll spend your refund at the banquet!); this year, it's simply Turkey day!



## Oregon State Police Report:

Trooper assisted a special agent with the BLM and a representative with DEQ on a site visit on a multi-dwelling property in the Butte Falls area with known environmental violations. When they arrived they found a tributary which feeds into the Rogue River that went through the back side of the property. Trooper located septic pipes connected to camp trailers which fed into the creek and miscellaneous trash throughout the entire property. Three individuals were cited criminally, two for water pollution and one for depositing trash within 100 yards of waters of the state.

On a recent Saturday Trooper checked anglers on the Rogue River. One angler and his daughter were fishing near Valley of The Rogue State Park and possessed a 8-inch wild steelhead smolt. The subject was warned for the offense. Several other anglers were checked near Rogue River, one 12 year old who did not have a license and tag was also warned. Working Lost Creek Lake just before dark, Trooper noted kayakers fishing the upper end of lake. One kayaker did not have a life jacket or AIS permit and was cited for the life jacket. The other kayaker had a life jacket but no AIS permit and she was warned for that infraction.

Trooper Pilot assisted the Jackson County Sheriff Office attempting to locate a male who had fled on foot from law enforcement in Gold Hill - he was not located. Trooper Pilot assisted ODFW in conducting a black-tail deer telemetry flight in the Applegate. Trooper Pilot assisted the Marine Fisheries Team with an aerial patrol of Cape Perpetua and Cascade Head Marine Reserves for illegal commercial crab gear. Gear was observed in the NE end of Cape Perpetua which was present in earlier flights, but new gear was also seen. Trooper observed strings of crab gear that were on the NW end of Perpetua very near the border of the reserve. Information was passed to Troopers on the water. No issues were observed in Cascade Head Reserve but rough ocean conditions made observations challenging.

Trooper retrieved one of three pellets from Wildlife Images that were removed from a hawk that succumbed to its injuries. Trooper found a property near where he collected the hawk that had ducks and chickens fenced in with no cover. Trooper contacted one of the residents and questioned him about a hawk shot last week and the individual was evasive. Trooper asked if the individual was possibly a juvenile and the individual shook his head, but also said that the juvenile was currently in California dealing with a custody issue and that he didn't want to be involved. Trooper left a card and asked for the parent of the juvenile to give him a call when they return. The case is still under investigation.

Trooper checking angling licenses at Agate lake observed an individual on the other side of the lake park his vehicle and unload what looked to be angling gear and a rod from his trunk and walk down to the shore. Trooper drove to the other side of the lake and when hiking near the location where the individual was last seen, the individual spotted the Trooper first and ducked behind some logs. Trooper approached and asked how the fishing was and the individual said that he hadn't been fishing while standing by an open can of dug through worms. Trooper also observed that the subject's line was wet. Subject denied having an angling or driver's license and was cited for no operator's license.

Trooper received information at the end of February about an individual that had a late bear check in at ODFW and that he had also tagged the bear the same day that he purchased his additional bear tag. The individual was located at a different address than the one listed on his hunter ID and interviewed about his success in taking a bear the same day he purchased a tag. The individual explained how it was his luckiest year with hunting bear and denied taking the bear before he had his bear tag. The individual was cited for late bear check in at ODFW as it was over three months late and reminded that his bear earlier that year was turned in within the time frame.

Trooper assisted the Special Investigations Unit with a residency investigation of two California hunters. Phone contact was made with both individuals and brief interviews conducted. Additional follow up and in person interviews are being set up. Pending charges await.

Trooper received a complaint on his day off of a possible illegal bear take. The RP sent a screenshot of small bear that he felt might be undersized/under age. Follow up revealed that the size of the bear was not illegal, but the take was. By checking the ELS it was determined that the suspect had purchased a fall bear tag at 4:07 pm on the opening day of archery season. The electronic validation of the tag took place at 4:21 pm on the same day. This led to the belief that the bear was shot earlier in the day and then purchased the tag to cover the illegal harvest. During the interview, the suspect admitted to shooting the bear at approximately 11:00 am. Subject was cited for unlawful take/possession of black bear. A shoulder mount and 26 packages of bear sausage were seized.

Trooper received a call that a homeowner in Ashland located a skinned head, hide and feet of a bear under his porch. The RP advised that the bear had an ear tag. Trooper responded and noted the bear tag was not an ear tag, but an ODFW tag issued when a bear head is checked in. The number on the tag indicated that the bear head was killed on a damage claim at a local orchard and was given to the individual that was living in the house where the bear was found. A call was made and the individual said he had just moved out of that house and completely forgot about the bear under the porch. No violations were involved and the person was informed if he wanted the smelly hide and head it would be located in the ODFW pit. The person was apologetic and advised he would probably not elect to pick it up.

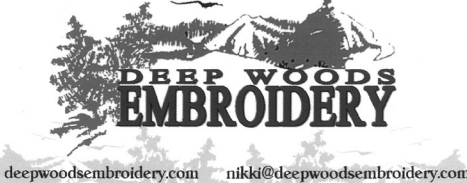

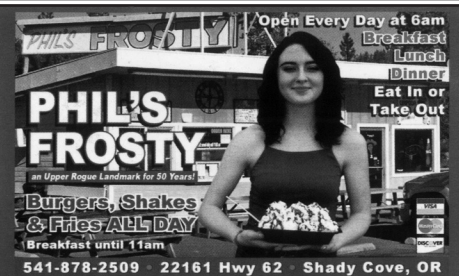

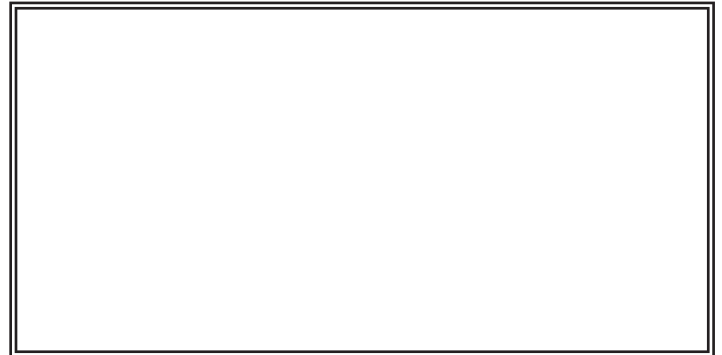
