## Anti-hunting, gun control petitions circulating

Anti-hunting and gun ownership initiative petitions are the focus of the OHA lobbyist team's work this summer. Signatures are being gathered for petitions that proponents have aimed for the ballot in November 2022. Here's the latest.

### IP13 Hunting, Trapping & Fishing Ban

The clock has begun for proponents to gather the 112,020 signatures needed by June 2022 to place initiative petitions on the November 2022 ballot.

OHA is working with two coalitions of farming, ranching, and sports groups

to form strong NO on IP13 campaigns.

More information on talking points and what members can do to help will be forthcoming as the coalitions develop campaign structures and move into the messaging phase.

IP13 would criminalize animal agriculture, making it virtually impossible to raise livestock, and it would also make hunting, fishing, and trapping activities illegal and classified as animal abuse.

### IP 17 & IP18 Gun Control Initiatives

Two gun control initiative petitions have been filed with approved ballot titles from the Oregon Attorney General. The proponents are now gathering signatures for these petitions for the November 2022 ballot.

**IP 17** - Imposes a new permit system to purchase a firearm and prohibits possession or use of magazines over 10 rounds.

**IP 18** - Prohibits manufacturing/possessing/transferring many semiautomatic firearms.

OHA is working closely with gun advocate groups to stop these two petitions.

# Video exposes Hwy 20 roadkills

The Burns Paiute Tribe recently released a video highlighting deer/vehicle collisions on Highway 20 between Juntura and Vale in eastern Oregon.

OHA partnered with conservation groups and agencies seeking solutions for wildlife passage on central Oregon Highway 97, where an 86-percent reduction in wildlife/vehicle collisions resulted from the underpass construction.

While Highway 97 is straight, forested and four lanes south of Bend where deer cross seasonally, this section of Highway 20 presents a different landscape and vegetation type. The deep Malheur River canyon and parallel Highway 20 bisect the mule deer winter range, where deer are forced to make numerous highway crossings in their wintering ground across a narrow, crooked highway with limited line of sight for drivers, a bad situation for deer and drivers.

There are many possible solutions to address the problem, such as using the existing river bridges as modified undercrossings, directional fencing, overpasses, and even electronic means to

signal drivers on the many blind corners.
