## OSP is cracking down on proper tagging.

If you are using paper tagging make sure that you have the correct tag and dates. Especially if you have a Sports Pac—yes you have a voucher but you need to go in to a store or go online yourself and make sure that you have an actual tag because the voucher listed in your portfolio is not a valid tag.

Remember to get the tag on the animal ASAP.

If you are actively winching something out and are worried about losing the tag then at the very least make sure that you validate the tag and have it with you so you can show that everything is ready to go.

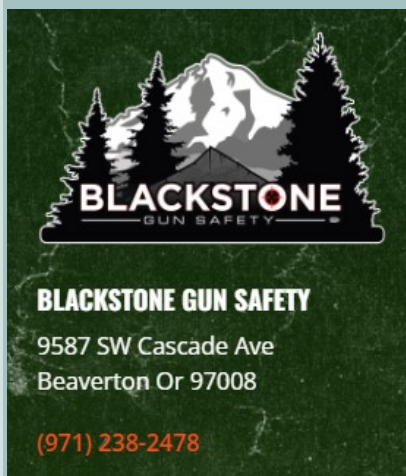
Make sure to have your phone charged and an extra battery or a way of charging if you are using e-tagging.

## A BIG THANK YOU to Bryan “Bear” Hall, Blackstone Gun Safety, Chief Range Safety Officer, NRA Certified Instructor and a Representative of Right to Bear.



Bryan talked to us about his company and his background as a bail enforcement agent in California for ten years, being a certified firearms instructor, teaching self-defense and gun safety education classes.

Oregon laws on self-defense are not clear cut and you can still be sued for protecting yourself if you show a firearm. Bryan went over several real life scenarios locally and nationally and the outcomes to those cases. In some where there was video and evidence seemed pretty clear cut, it still cost thousands if not a couple hundred thousand to go through these court cases.

*What if the unthinkable happens and an event occurs where you have a self-defense incident—what do you do now?* If you have Right to Bear insurance then it's pretty simple, you simply call them and they will walk you through next steps and answer any questions.

**This coverage is \$15 per month or \$165 per year (One time processing fee of \$15)**

\*Unlimited Civil Defense coverage which allows you to choose your own attorney in the event you are sued after a self-defense incident. (They pay, this is not a reimbursement)

\*Unlimited Criminal Defense coverage provides legal support in the event you are criminally charged after a self-defense incident. ( You choose your own attorney) (They pay, this is not a reimbursement)

\*Expert Witness coverage will provide an “expert witness” to testify on your behalf. (Again, they pay)

\*Psychological support provides coverage for counseling sessions due to stress/trauma experienced from a self-defense incident. (They pay, this is not a reimbursement)

\*Gun Replacement—they will replace your gun if taken after a self-defense incident.

\*Firearm & Self-defense Training & Education

\*Quarterly Firearms Newsletter

**Additional coverages you can add on for a fee are;**

\*Multi State coverage offers you protection in 50 states. Residents of New York, New Jersey, and Washington do not qualify for their membership however members are still covered there. \$35 year

\*Bail Bond Reimbursement provides money for bail up to \$100,000. \$35 year

\*Additional Associate coverage extends to coverage to a spouse or household partner. \$35 year

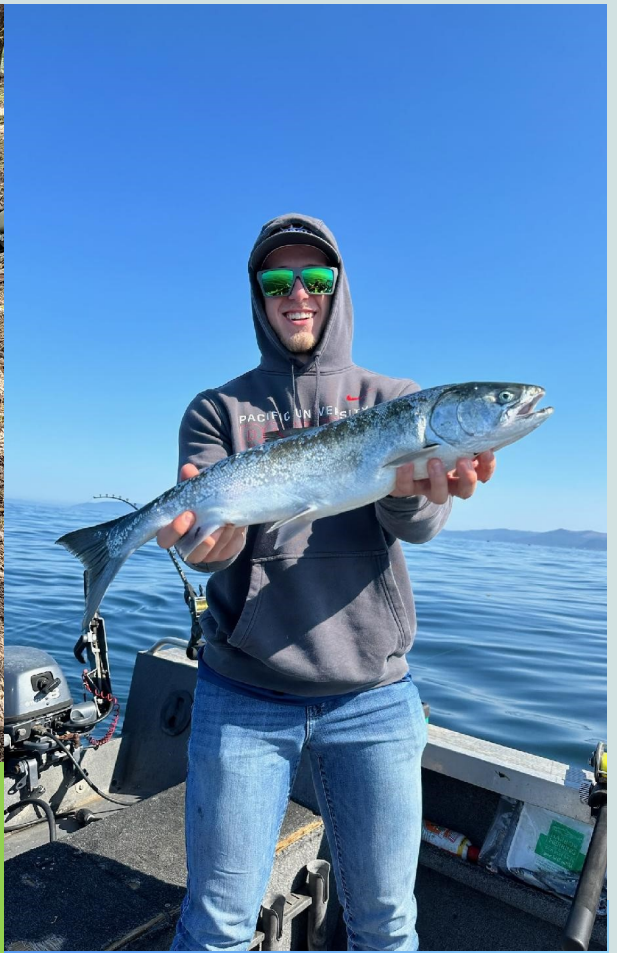
\*Minor household children \$35 year

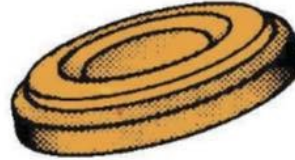
