**A BIG THANK YOU** to Howard Baker of the Timber Beasts BB Gun team for being our June speaker. The Timber Beasts have been around for over 45 years. Participants range from ages 8 to 15 years old. They teach marksmanship, discipline, self-control, responsibility, gun safety, types of firearms, safe carries, determining dominant eye, building a proper site picture, shooting positions, range commands, integrity, teamwork and positive characters traits that are life-time lessons. The Timber Beasts are a club dedicated to the education of safe gun handling and the discipline of marksman shooting, their motto is **Promoting a Positive Shooting Experience**.

They have two sessions the first is 6 weeks, they must attend the first to be able to be eligible for the extended session. They create five member teams who compete to go to Nationals in Rogers, Arkansas. They shoot in four shooting positions—standing, sitting, prone and kneeling. They shoot a muzzle-loaded single-shot BB Gun, the Daisy AVANTI Champion Model 499, billed as the most accurate BB gun in the world. The guns cost \$105 each. They don't really have the facility to handle a large turn out of students so they don't really advertise it anymore, they rely on word of mouth. They shoot out of the Knights of Pythias building in Forest Grove.

At one time there were up to 12 teams on the West Coast however now the Timber Beasts are the one and only program of it's kind on the West Coast. When they go to compete at the State level they have to split up their shooters into different teams to compete against each other.

The Timber Beasts fundraise all year to cover 100% of the trip to Rogers, Arkansas for the shooters and coaches—that's a five shooter plus two alternate team and they have to pay for airfare, room and board and food. It's a great experience for the shooters. Participants that make it to Nationals must sit out a year in between trips due to the educational requirement.. They get help from organizations like OHA, they take their BB Gun Range to events to earn money and offer help to earn money. To earn their funds to go to Nationals. At Nationals, they compete with 72 other teams across the USA—there is no classification break between ages so a 5 year old could be shooting against a 15 year old. They shoot in all four positions. There is also a written gun safety test. Each of the 5 parts is worth 100 point for a maximum score of 500. The competitors compete both individually and as a team. Awards are given for each individual position as well as top individual score and top aggregate team scores. Nationals are in the first week of July.

Something people may not know is that 60+ colleges give out scholarships for shooting sports.

## Key bills still hang in balance

As the June 29 ending to the 2025 state legislative session approached, several major bills of importance to Oregon hunters still hung in the balance.

Bills with positive impacts for OHA's mission to protect Oregon's wildlife, habitat, and hunting heritage include:

- **HB 2978** increases collaboration between ODOT and ODFW regarding wildlife crossing structure design, location, and implementation. Signed by the Governor.
- **SB 812** removes the sunset clause on the Landowner Preference Program. Signed by the Governor.
- **SB 777** assigns a multiplying factor for livestock and guard dog compensation due to wolf depredation. Signed by the Governor.
- **HB 5009** sets the ODFW agency budget for the next biennium. Passed both House and Senate.
- **HB 2342** increases fees for tags and licenses. While the sportsmen's community is never excited about higher prices, OHA has supported this bill due to inflation and maintaining current service level needs. Passed the House and in process in the Senate.

A bill that will negatively impact the sportsmen's community is **HB 3932**. The bill bans beaver trapping on federal and state lands in waterways deemed impaired by the Department of Environmental Quality. The bill sets a troubling precedent of removing wildlife man-

agement decisions from the purview of ODFW and the Commission. Headed to the Governor's desk.

Bills that have not been finalized at the time of writing:

- **HB 2167** would appropriate \$3.5 million to the Oregon Veterinary Diagnostic laboratory at Oregon State University for chronic wasting disease research and testing. The bill is currently waiting in Ways & Means.
- **HB 2977** would increase the state transient lodging tax by 1.25% to fund ODFW programs such as the Statewide Action Plan, wolf compensation funding, wolf biologist, invasive species funding, wildlife stewardship and anti-poaching funding. The bill has passed out of the House and is currently in the Senate.
- **HB 3075** seeks to implement Measure 114 plus additional restriction on firearms purchases. The bill has a large fiscal and is waiting in Ways & Means.
- **HB 3076** builds a new division of the Department of Justice to create and implement a state-level regulatory system for firearms dealers that are redundant and more restrictive than the federal regulations already in place. This bill has a large fiscal but is currently moving through the Ways & Means process with intention.
- **SB 243** bans rapid fire trigger mechanisms and adds new restrictions on concealed carry ability in public spaces and buildings. The bill has a substantial fiscal and is currently moving through Ways & Means with intention.

## State Supreme Court to review M-114

The lawsuit against Measure 114 has reached the Oregon Supreme Court.

Measure 114, the gun control ballot measure passed by a narrow margin in 2022, was ruled unconstitutional by Harney County Judge Raschio in November 2023.

At that time, the State of Oregon appealed to the Oregon Court of Appeals, which took up the case and issued a ruling in March 2025 stating the measure did not violate the state constitution.

The plaintiffs petitioned the Oregon Supreme Court to review the ruling of the Court of Appeals, which was accepted, and the case is scheduled to begin in November.

# Public lands up for sale

Members of the Senate Energy and Natural Resources Committee are pushing to include a major sell-off of public lands as part of the overall budget bill that congress is working on. This has prompted a letter co-signed by OHA and many of our conservation partners to our Oregon delegation to oppose this action. Earlier, the House had considered a similar mandate, but in the end decided to drop that provision.

According to a press release from the Congressional Sportsmen's Foundation, the proposed language includes "the mandate to arbitrarily sell-off at least 2 million acres and up to 3 million acres of federal public lands across 11 western states."

Finding specific information on which lands are being considered to meet this mandate is difficult.

A key difference between the long-established process and criteria for disposing of federal public lands and what is now being proposed has to do with both the amount of land (massive acreages) and the process used to identify and sell the lands. Currently, the Federal Land Policy and Management Act (FLPMA) and the Federal Lands Transaction Facilitation Act (FLTFA) set clear processes and criteria, including public input, for disposing of, or even trading lands in a land exchange. The proposed bill language would strip most of this away.

Another element of the FLTFA process is that 96 percent of proceeds from the sale of land is reinvested into conservation and access by sending the revenue to an account to be used to acquire higher value lands. As hunters, we might think of this as selling a "low value" piece of federal land (perhaps one that is landlocked and not accessible to the public), and then using the proceeds to buy other lands of higher value. The Senate reconciliation language eliminates this reinvestment into public lands and sends 90 percent of the proceeds from the proposed land sales at hand back to the U.S. Treasury.

OHA is invested in keeping Oregon a CWD-free state for as long as possible, but early detection of the disease if and when found in Oregon is critical to limit the spread. CWD is a fatal disease capable of drastic negative impacts on deer, elk and moose populations.

It's easy to submit CWD samples at ODFW check stations, ODFW field and district offices, and cooperating taxidermists and meat processors.
